## **ADVERTISEMENT**

Online applications are invited from Arunachal Pradesh Scheduled Tribe (all the two posts are reserved for APST candidate) for filling up 2 (two) posts of Computer Programmer Group- B (Non Gazetted), under the establishment of Arunachal Pradesh Public Service Commission, Itanagar in Level 7 Rs.44,900 - 1,42,400 under Pay Matrix of 7<sup>th</sup> Central Pay Commission plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

# (1) EDUCATIONAL QUALIFICATION: Candidate applying for the post must possess:-

A. Master Degree in Computer Science/Computer Applications OR BE or B.Tech in Computer Application OR Information Technology from a recognized University

B. Must have knowledge of one or more Programming Languages like VB, C, C++, C# and with web designing/Scripting and HTML/DHTML, ASP Programming etc. and back end software like MSSQL, Oracle etc.

### (2) AGE LIMIT:

The candidates must have attained 21 years of age and should not be more than 32 years as on **23.08.2019** However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation to APST candidates for A P state govt. employees.

#### (3) METHOD OF SELECTION :-

The eligible candidate will have to appear in the written examination in the following subjects:-

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce test. In other words selection for viva-voce test shall be based on the aggregate total marks secured in the

written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test.

N.B The Commission will conduct recruitment test (Objective Type) before written examination, if it is deemed necessary to do so.
