Out of 3 Posts,2 posts are reserved for APST candidates and 1 post are unreserved. The vacancy position is subject to variation.

- 1. <u>AGE</u>: The candidates must have attained 18 years of age and should not be more than 32 years of age as on 30/04/2019. However the upper age limit is relaxable in accordance with the instructions issued by the Govt. of Arunachal Pradesh from time to time.

- **METHOD OF SELECTION:-** The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service commission at Itanagar on the basis of which selection will be finalized.
