#### ADVERTISEMENT

District e-Governance Society East Kameng (DEGSEK) established on 1<sup>st</sup> February 2011 on the guidelines of Government of India to strengthen the support work related to e-Governance activities. In reference to Memorandum No- NIL, dated, New Delhi, the 17<sup>th</sup> November 2015, manpower support to DEGSEK has been proposed with 2 (two) district level manpower resources (2 District Managers) under CSC 2.0 scheme of GoI. The post is purely on "contractual" basis for one year and necessarily further extendable year-wise for a maximum period of 4 (four) years.

Applications are hereby invited from the **resident of the East Kameng District** for the 2(two) District Managers post with the below eligibility criteria.

- 1. <u>Number/Nature of vacancies:-</u> 2 (two) on purely contractual basis for one year and necessarily further extendable year-wise for a maximum period of 4(four) years.
- 2. Monthly remuneration:- ₹25,857/- (consolidated)
- 3. Eligibility Criteria:-

## A. Essential Qualifications:

- i) Graduate in any Discipline
- ii) Must have at least CCC level proficiency in computer from NIELIT
- iii) Minimum of two(2) years of relevant work experience preferably in IT/e-Governance/IT related project co-ordination and program management in related fields
- iv) Should be able to communicate in English and local language
- v) Should be aged between 24-35 years as on 01.12.2015
- vi) Should be resident of East Kameng District.

## B. Desired Skills:-

- i) Prior project management experience.
- ii) Experience in the domain of IT projects, IT infrastructure deployment/ software development, hardware, networking, security management in IT projects.
- iii) Good people management and communication skills.
- iv) Result oriented and self-motivated for working in rural areas and cross reporting structure.
- v) Experience in e-Governance related projects of organizations/ departments/ NGO/ Non-profit Organization
- vi) Willingness to travel across the district at Gram Panchayats.



## 4. Roles and Responsibilities:-

- i) Supporting DeGS in Program management and last mile implementation in all the Gram Panchayats within the respective District Administration.
- ii) Coordinating with State teams, CSC SPV (Common Service Centre Special Purpose Vehicle) teams and national team for smooth implementation.
- iii) Working with DeGS for selection of VLEs (Village Level Entrepreneur), CSC locations and enabling factors ensuring smooth operations of CSCs.
- iv) These resources would be the first point of contact for redressing VLEs' issues and the issues raised at the Help Desk.
- v) These resources would facilitate the capacity building and training activities conducted by CSC SPV and State/UT in the district for increasing sustainability of CSCs.
- vi) Coordinating with other State/UT departments along with State teams for enablement of more services into the CSC platform and integrating existing services/portals into the universal CSC technological platform.
- vii) Conducting regular field level assessments of CSCs within district. It is proposed to provide Geo-Tagged application support to these resources for undertaking regular field visits of CSCs within their operational district providing a hand-hold support to VLE.
- viii) Coordinating with DeGS for review meetings on implementation progress within district.
- ix) Supporting DeGS in implementation, decision making and all other activities assigned by DeGS.
- 5. **Method of recruitment:** The eligible candidates will have to appear for the written/computer test to be conducted at Seppa. The Syllabus for the written/computer test will be same as of NIELIT-CCC level. Only maximum of top 5 (five) candidates will be qualified for viva-voce. To arrive the final merit list the ratio for the written/computer test and viva-voce will be 70:30.
